ORDINANCE NO. 372

AN ORDINANCE AMENDING SECTION 115.07 OF THE CODE OF ORDINANCES OF THE CITY OF STATE CENTER, IOWA, BY CHANGING "CHECK" TO <u>PAYMENT</u> AND "BANK" TO <u>FINANCIAL INSTITUTION OR CREDIT COMPANY</u> UPON ITS FINAL PASSAGE, APPROVAL AND PUBLICATION AS PROVIDED BY LAW.

BE IT ORDAINED by the City Council of the City of State Center, Iowa:

SECTION 1. SECTION MODIFIED. Section 115.07 of the Code of Ordinances for the City of State Center, Iowa, is amended to reword the paragraph by changing "check" to <u>payment</u> and "bank" to <u>financial institution or credit company</u> for the purpose of applying a service charge when a customer's payment for utility service is returned by the financial institution or credit company it is drawn on:

115.07 RETURNED PAYMENT CHARGE. In the event a customer's payment is returned by the financial institution or credit company on which it was drawn, the customer shall be required to pay a service charge of \$30.00.

SECTION 2. REPEALER. All ordinances or part of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision, or part of this Ordinance shall be adjudged invalid, unconstitutional, or unenforceable for any reason, such adjudication shall not affect the validity or enforcement of the remaining provisions.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect upon its final passage, approval and publication as provided by law.
