ORDINANCE NO. 378

AN ORDINANCE AMENDING THE STATE CENTER ZONING ORDINANCE OF 2020, OF THE CITY OF STATE CENTER, MARSHALL CO., IOWA, BY AMENDING THE OFFICIAL ZONING MAP AND ZONING DISTRICT BOUNDARIES OF THE CITY OF STATE CENTER, IOWA, BY DESIGNATING THE ZONING CLASSIFICATION OF CERTAIN PROPERTIES, NOW KNOWN AS:

THE SOUTH 15.0 FEET OF THE NORTH 75.0 FEET OF LOTS 1 AND 2 AND THE SOUTH 15.0 FEET OF THE NORTH 75.0 FEET OF THE EAST 45.0 FEET OF LOT 3, ALL IN BLOCK 16 OF THE ORIGINAL TOWN OF STATE CENTRE, MARSHALL COUNTY, IOWA FROM A R2-RESIDENTIAL: SINGLE-, TWO- & MULTIPLE-FAMILY DWELLINGS DISTRICT, TO A C1-COMMERCIAL: HIGHER DENSITY DISTRICT

BE IT ENACTED by the City Council of the City of State Center, Iowa:

SECTION 1. The Official Zoning Map and the Zoning District Boundaries of the City of State Center, Iowa, are amended by designating the zoning classification of the following described property as C1: Commercial Higher Density as requested by Brian's Collision Clinic, LLC., owner;

With the following conditions:

1. The owner shall meet all applicable City, State, and Federal codes and ordinances required with the use of and building upon said property.

SECTION 2. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 3. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
